# **Operation CBA 2018:**Bargaining Work is Underway!

The current AAFMCC Contract with MCC expires in August of 2018, and that means that this will be a busy yet exciting year. There is power in numbers, and the strength of our new contract is dependent on your involvement and support. Adjuncts make up the majority of the teaching staff at MCC, and it's time for unity, for action, and for genuine change. MCC's students wouldn't be successful without the 632+ of us who instruct, mentor, and inspire them. MCC thrives because of us. Our 2018 contract must reflect our significance and must account for the value that we bring to our students and to our institution.

In May, The AAFMCC Executive Board circulated a call for interested bargainers, and we now have a bargaining team in place for upcoming negotiations. The team will consist of the following five bargainers: Ranae Ikerd Beyerlein, Ph.D. (Biology), Rick Fenwick, Ph.D. (Psychology), Jeffrey T. Kass (History), Jodi Monday (MACA), and Greg Sims (Chemistry). Yvette Griffin, Ph.D. (Information Technology/ Microsoft Office) will serve as our alternate bargainer. Ginger Roehr from ATF Michigan will also be assisting us in our bargaining efforts, and Jane Asher, Ph.D. (English) will be serving as our researcher.

The Bargaining Team had its first meeting on June 19th and plans to begin bargaining talks with the college at the beginning of the Fall 2017 Semester. This will be the most important negotiation since the inaugural contract back in 2004, and we are dedicated to making significant improvements for MCC adjuncts. The Executive Board will be circulating several surveys and will be holding meetings in order to determine our bargaining priorities and to ensure that our bargaining efforts reflect the desires of our members. Please look for these surveys in your MCC e-mail, take the time to fill them out, and make an effort to attend a meeting this year. Our union is nothing without its members.

### **Explanation of Dues and Election of Fee Payer Option**

It is required that all MCC Adjuncts fill out a union form declaring themselves a full member of AAFMCC or an Agency Fee Payer. Full members pay a dues rate of 1.75% while Agency Fee Payers pay a rate of 1.6%. Full members enjoy certain union rights and benefits including the right to vote and participate in union meetings, eligibility for union posts, and participation in the AAFMCC Scholarship and Tuition Reimbursement Programs.

If you have not yet filled out a form, you need to do so. Furthermore, any member who declared him/herself a fee payer and wishes to switch to a full member may also obtain a new form at the e-mail listed above.
